Business meeting of April 12, 2022. The meeting was called to order at 6:30 pm.

## Old Business:

- 1. March's meeting minutes were read and approved.
- 2. Treasurer's Report: Beginning Balance as of 3/01/2022: \$11,477.46. Total Deposits: \$760.05. Total Expenses: \$61.59. Ending Balance as of 3/31/2022: \$12,175.92. We discussed a budget and agreed with Marla's projections.
- 3. Improvement project: Bryant met with STR and we should hear by the end of April how much turf they can donate. Installation could happen in June or July.
- 4. Repairs & Maintenance
  - a. Mark (lawn mower) will remove the logs left from the fallen trees. Two additional trees need to be removed. Anne will contact Public Works about all the tree removals.
  - b. Luis and Colin fixed the fence and will submit receipts for the supplies.
  - c. Drainage and erosion control. Our lawncare team quoted \$1.500 to install a French drain. Bryant and Susan will contact other landscapers.
  - d. Maureen will arrange for mulch delivery.
  - e. Marla signed Mosquito Joe to treat the park in exchange for advertising.
- 5. Website issues: phone calls and emails were not returned.
- 6. Junior Rotary offer: we will ask them to donate what they can toward the installation of the new mounds.
- 7. "Chester's Gazebo" is the name we settled on and Bryant will contact his vendor.

## **New Business:**

- Bryant and Maureen will arrange to purchase 20 new chairs.
- 2. Membership gate check: weather permitting we will do it April 23-24th
- 3. Facebook: James and Rebecca offered to help us with our social media. Patrons could check in and access their accounts to check membership status or report a problem. They will work with Rita and Maureen to sync and update accounts.
- 4. Website: We agreed to update our board member bios and include photos of us with our pets. We also hope to get a photo of the board members together. We plan to include dog names in our membership database again as well as photos to help with identifying problem dogs.
- 5. Rita will shop for a solar powered trail cam and an electric cam for the shed
- 6. Anne will consider wording of an incident report or a guide to dealing with dog fights and injuries.
- 7. Volunteer work days: we aim to set up a Saturday in May (possibly May 7<sup>th</sup>) to spread mulch, clean signs and chairs, clear vines from the fence,,,
- 8. Fundraiser: Bryant will assemble a team to plan our Halloween festival and vendor showcase.
- 9. Dennis Hera was made an honorary member for his invaluable service.
