

## Peachtree City Dog Park Association

Business meeting of June 14, 2022. The meeting was called to order at 6:27 pm.

In attendance were President Bryant Goss, Vice President Anne Myers, Treasurer Marla Curley, Secretary Rita Wilkinson, Director Susan Acosta, Director Maureen Kuebler, Luis Galindo, Dan Aikin and canine ambassadors, Gatsby and True-man.

### Old Business:

1. May's meeting minutes were read and approved.
2. Treasurer's Report: Beginning Balance as of 5/01/2022: \$11,969.85. Total Deposits: \$761.35. Total Expenses: \$576.77. Ending Balance as of 5/31/2022: \$12,154.43.
3. Improvement project: STR still hasn't received approval from their corporate office. Installation could still happen in July.
4. Repairs & Maintenance
  - a. Trees are still marked for removal. Anne will follow up with Public Works
  - b. Heard Landscaping was delayed due to illness but will spread soil and mulch on Monday, June 20. Announcements will be posted on our website, facebook and in the park.
  - c. Bryant has purchased markers to replace the posts in the park.
  - d. We discussed improving the appearance of the park by painting the bag dispensers a bright color, adding decorative stickers to the water buckets or maybe wooden planters with removable bucket liner.
  - e. We will ask Tara's group to contribute to the mound construction.
5. "Chester's Gazebo" sign is being created and will be ready for our approval soon.
6. Another membership gate check will occur soon, after the volunteer day, probably after the 4th.
7. Volunteer Work Day: will be scheduled after the landscaping crew is done, aiming for Saturday, June 25<sup>th</sup> 8am – 10am. We will wipe down and straighten benches, chairs, scrub the cement pad with vinegar, clear the fence line. We will post this on the web page, facebook and in the park.
8. Surveillance cameras: Susan has taken over the research.
9. Incident Report: Anne is still working on wording.
10. 4<sup>th</sup> of July Parade: Maureen will purchase candy. Bryant has approached people to walk beside the carts to pass out candy, dog treats, pamphlets... Decorations are in the shed along with signs and banners.
11. Rita will take over creating the QR codes.
12. Our most recent ByLaws will be posted to the website.
13. Mayor Learnard will meet with us after the 4<sup>th</sup> to discuss needs and ideas.

### New Business:

1. Website: Our current database needs to be rewritten due to its age and multiple volunteer attempts to fix and update it over the years. Initial costs to rewrite, host and support are much higher than we can afford. We will look for sponsors to help with the cost while also looking for developers who could rewrite the database without hosting and a support retainer.
2. Anne will look into our insurance coverage to make sure it is adequate.
